\*NB, some departments responded to *Reform*'s Freedom of Information request with information that they held on the number of full-time equivalent staff working in sponsorship rather than headcount.

Since one FTE staff member is equivalent to at least one unit of headcount, combining the number of FTE staff with the headcount of public body staff gives a minimum headcount of staff across these two categories. Though it is possible that the total headcount of staff working in these functions is in fact higher, as one full-time equivalent staff member could be equal to a headcount of several part-time staff.

#### 2.2 Staff employed in public affairs

Some public bodies responded to the FOI request with a breakdown of the headcount of staff employed in communications, marketing, press and public affairs. Those which specified the headcount of staff employed in public affairs are detailed in the table here.
